## POWERBALL® ADVANCE PLAY® REFUND

DEADLINE FOR REIMBURSEMENT CLAIM IS DECEMBER 31, 2020

The California State Lottery (Lottery) is committed to our players, and values your support of our mission to provide supplemental funding to California public schools. As a result of the recent announcement regarding the change in the starting Powerball Jackpot and the minimum rolling amounts, the Lottery will reimburse players who meet the following requirement:

- Any player who purchased an Advance Play Powerball ticket on or before April 2, 2020, for draws after March 25, 2020.

You can keep your ticket and will remain eligible to claim any prize associated with your ticket. The Lottery must receive your reimbursement claim form on or before December 31, 2020, for reimbursement.

- Make a **COPY** (front only) of your Advance Play Powerball ticket as proof of purchase. **(PLEASE DO NOT SEND YOUR ORIGINAL TICKET)**
