### ***Lucky \$1 Million Scratchers® Sold in Winters***

#### ***A New Lucky Retailer is Made Along Putah Creek***

**SACRAMENTO** – Winters Wine & Liquor at 192 E. Grant Avenue in Winters has made a cool new millionaire. The California Lottery confirms a \$1 million Scratchers game was sold in the Central Valley town known for its apricots and wine. Winters Wine & Liquor will earn the official [Lucky Retailer](#) status in a city full of California Lottery Lucky Retailers. Selling a winning game worth \$1 million or more also awards the retailer a bonus of half of one percent of the prize. For this prize, the bonus amounts to \$5,000 for the Winters shop.

“Winters is a nice little town,” says Parvinder Malhi, who owns the store with a partner. “We love the city and thank everybody here for supporting our business.”

Malhi says they plan to reinvest the bonus in the business and the community. When it comes to the mission of the California Lottery, Parvinder is all in.

“If it helps students, kids, and makes people’s lives better, why wouldn’t it be a great thing? Anything that helps people goes hand in hand with what we believe in,” said Malhi.

### ***For the Winner’s Name, You’ll Have To Wait***

The winner of the \$1 million prize needs to go through the standard claims process for big winners. Once they come forward, the

process involves being vetted by California Lottery law enforcement officers to verify the legitimacy of the win. After the claims process is complete, which usually takes about 6-8 weeks, the winner receives their prize, less appropriate federal taxes. California does not tax California Lottery winnings.

The rigorous vetting process for any major win underscores the California Lottery's commitment to maintaining public trust and ensuring that prizes are awarded to rightful winners.

## ***40 Years of Play and Counting!***

Since 1985, the California Lottery has fulfilled its mission of providing supplemental funding to public education while paying more than \$90 billion to Lottery winners in every corner of the state. Out of the \$154.4 billion in revenue generated by California Lottery sales over the past 40 years, over 95% -- a total of \$147.3 billion -- has returned to local communities in retailer compensation, contributions to education, and prize payouts.
